Information Sought:

The appellant sought action taken report on his letters dated 29.08.2012 & 16.11.2012 addressed to the Director, BARC regarding tampering in the relevant entries of Attendance Register.

Relevant facts emerging from hearing:

The appellant is not present while the respondent is present and heard through video conferencing. The appellant filed an RTI application on 17.01.2013 seeking the above information. CPIO vide his letter dated 12.02.2013 informed the appellant regarding action taken on his above referred letters. He further intimated to the appellant that his attendance record months of April, 2012, May 2012, October, 2012 and November, 2012 from the muster maintained in Time Office of RRMD and copies of muster taken from the IVS system have been compared and it is found that no tampering has been done in any of the musters. Not satisfied with the reply of CPIO, the appellant filed an appeal on 13.03.2013. FAA vide his orders dated 01.04.2013 upheld the response of CPIO and stated that PIO can provide the

information available in material form and is not expected to settle the grievance of the applicant.

The respondent stated that complete information as available on record has already been furnished to the appellant. He stated that the appellant has a grievance and redressal of grievance is beyond the purview of the RTI Act. He stated that appellant may approach the appropriate authority for redressal of his grievance. As the appellant is not present, his views could not be ascertained.

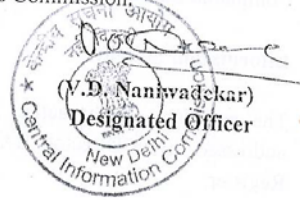
Decision:-
