Accordingly in both the cases, the appellant has submitted before the Commission that he does not wish to pursue the matter/s any further and has sought permission to withdraw the appeals filed before the Commission. The Commission permits the appellant to withdraw both the appeals. The Appeals are, therefore, dismissed as withdrawn.
